“Birdie Prepayment Offer” Terms and Conditions

1. From now to 31 August 2026 (or such other date that may be otherwise determined by Birdie) (both days inclusive) (the “**Offer Period**”), Birdie customers who successfully subscribe the designated monthly plans using the promotional code “PREPAYBB” during the Offer Period (the “**Eligible Customer**”). Each Eligible Customer shall be entitled to monthly fee discount, monthly extra data, travel day pass and free upgrade to full speed offer for designated monthly plans once (the “**Offer**”). “**Birdie**” or the “Company” means Birdie Mobile Limited.
2. The customer must continuously subscribe to one of the specified monthly plans below to be eligible for the Offer:
 - a. The Birdie Mobile Unlimited Data Standard Monthly Plan (Monthly fee: HK\$250/month) includes the following services:
 - (i) monthly 30GB 42Mbps local data free upgrade to full speed; and
 - (ii) unlimited thereafter local data usage up to 21Mbps; and
 - (iii) unlimited 42Mbps local data during Owl Time (every day from 1:00a.m. to 6:00a.m.); and
 - (iv) unlimited local voice call minutes per month; and
 - (v) voicemail, call forwarding, call number display, call waiting and conference call.

The Offer includes: First month fee waiver, thereafter HK\$102 off monthly fee, extra 30GB full speed local data every month and 24 days of Asia 12 travel day pass (Receive 6-day on the 1st billing month; 2-day each month from the 4th to 12th billing month). When registering for the service, customers are required to prepay the first 3 months' fee after deduction of the monthly fee, which is HK\$296.

- b. The Birdie Mobile 15GB Standard Monthly Plan (Monthly fee: HK\$200/month) includes the following services:
 - (i) monthly 15GB 42Mbps local data free upgrade to full speed; and
 - (ii) unlimited thereafter local data usage up to 2Mbps; and

- (iii) unlimited 42Mbps local data during Owl Time (every day from 1:00a.m. to 6:00a.m.); and
- (iv) unlimited local voice call minutes per month; and
- (v) voicemail, call forwarding, call number display, call waiting and conference call.

The Offer includes: First month fee waiver, thereafter HK\$72 off monthly fee, extra 15GB full speed local data every month and 24 days of China & Macau travel day pass (Receive 6-day on the 1st billing month; 2-day each month from the 4th to 12th billing month).

When registering for the service, customers are required to prepay the first 3 months' fee after deduction of the monthly fee, which is HK\$256.

- c. The Birdie Mobile 9GB Standard Monthly Plan (Monthly fee: HK\$160/month) includes the following services:

- (i) monthly 9GB 42Mbps local data; and
- (ii) unlimited thereafter local data usage up to 2Mbps; and
- (iii) unlimited 42Mbps local data during Owl Time (every day from 1:00a.m. to 6:00a.m.); and
- (iv) unlimited local voice call minutes per month; and
- (v) voicemail, call forwarding, call number display, call waiting and conference call.

The Offer includes: First month fee waiver, thereafter HK\$62 off monthly fee, extra 7GB local data every month and 12 days of China & Macau travel day pass (Receive 3-day on the 1st billing month; 1-day each month from the 4th to 12th billing month).

When registering for the service, customers are required to prepay the first 3 months' fee after deduction of the monthly fee, which is HK\$196.

- d. The Birdie Mobile 6GB Standard Monthly Plan (Monthly fee: HK\$120/month) includes the following services:

- (i) monthly 6GB 42Mbps local data; and

- (ii) unlimited thereafter local data usage up to 2Mbps; and
- (iii) 3000 local voice call minutes per month; and
- (iv) voicemail, call forwarding, call number display, call waiting and conference call.

The Offer includes: HK\$59 off monthly fee for first 3-month, thereafter HK\$52 off every month.

When registering for the service, customers are required to prepay the first 3 months' fee after deduction of the monthly fee, which is HK\$183.

- e. The Birdie Mobile 2GB Standard Monthly Plan (Monthly fee: HK\$70/month) includes the following services:

- (i) monthly 2GB 42Mbps local data; and
- (ii) unlimited thereafter local data usage up to 128Kbps; and
- (iii) 2000 local voice call minutes per month; and
- (iv) voicemail, call forwarding, call number display, call waiting and conference call.

The Offer includes: HK\$25 off monthly fee for first 3-month, thereafter HK\$20 off every month.

When registering for the service, customers are required to prepay the first 3 months' fee after deduction of the monthly fee, which is HK\$135.

- f. The Birdie Mobile 600MB Standard Monthly Plan (Monthly fee: HK\$50/month) includes the following services:

- (i) monthly 600MB 42Mbps local data; and
- (ii) unlimited thereafter local data usage up to 128Kbps; and
- (iii) 1000 local voice call minutes per month; and
- (iv) voicemail, call forwarding, call number display, call waiting and conference call.

The Offer includes: HK\$12 off monthly fee every month.

When registering for the service, customers are required to prepay the first 6 months' fee after deduction of the monthly fee, which is HK\$228.

3. For Eligible Customers who have successfully registered and activated designated service plan, direct fee deduction will be made to customer's monthly bill, the extra data will be released to the Eligible Customer's "Gift Box" of Birdie Mobile App and the travel day pass will be added to the balance of "Day Passes" in Birdie Mobile App within seven working days upon every monthly successful payment. Designated service plan shall be upgraded to full speed local data.
4. Limited Offer
 - a. Customers who successfully register for designated Birdie monthly plans between 18 June 2026 to 30 June 2026 (both days inclusive) and successfully activate the service by 31 July 2026 will receive the "Birdie Summer Reward" ("8th Anniversary Rewards"), which includes in the form of redemption codes:
 - i. To enjoy an additional 28GB of local full speed data each month for 12 months (applicable to customers who register the above Birdie Mobile 30GB Standard Monthly Plan).
 - ii. To enjoy an additional 18GB of local full speed data each month for 12 months (applicable to customers who successfully register for the above Birdie Mobile 15GB Standard Monthly Plan).
 - b. The Company shall deliver the redemption codes for the 8th Anniversary Rewards to customer's email address registered with the Company within two weeks after the service becomes effective ("Redemption Email"). Customer should make sure they can receive the Redemption Email from the Company.
 - c. Customer shall redeem such 8th Anniversary Rewards in accordance with the terms and conditions as provided in such Redemption Email including but not limited to redeeming the code within 30 days of issuance of the Redemption Email within "Gift Box" of Birdie Mobile App.
 - d. Once successfully redeemed, the Company shall issue a Birdie 8th Anniversary Reward to the customer's "Gift Box" within Birdie Mobile App on a monthly basis for twelve (12) continuous months so long as the customer is still using the eligible Birdie service plan according to Clause 4a at the time of the Company issuing the Birdie 8th Anniversary Reward during such continuous period. It is the customer's sole responsibility to manage and timely activate such Birdie 8th Anniversary Reward at Birdie Mobile App. Only upon successful activation of such Birdie 8th Anniversary Reward the customer shall receive and use the additional local data as entitled hereunder until the end of that bill month (last day inclusive). Any unused data of that bill month shall be automatically forfeited.

- e. Each Birdie 8th Anniversary Reward issued has a validity of 90 days and shall automatically expire when lapsed and be removed from the customer's "Gift Box" within Birdie Mobile App.
 - f. The Limited Offer and any unused Birdie 8th Anniversary Reward shall be forfeited and removed automatically upon any eligible Birdie service plan being terminated or disconnected for whatever reason. For avoidance of doubt, any customer switches to any ineligible Birdie service plan before the Company issuing of the next month's Birdie 8th Anniversary Reward shall forfeit his/her entitlement to the Limited Offer while keeping their unused Birdie 8th Anniversary Reward issued. Customers can still use the Birdie 8th Anniversary Reward issued before the expiry.
 - g. All redemption codes under this Limited Offer are strictly for personal use by the same customer receiving codes. If the Company discovers or suspects that any person entitled participated in any illegal, fraudulent, deceptive or unfair behaviours or otherwise breaching the terms and conditions of the Company, the Company reserves the right to disqualify their rights to redeem, receive or use any offer, rewards or benefits and/or immediately suspend their account and/or take any other action it deems appropriate without notice.
 - h. The Company reserves the right to make the final decision on this offer and any disputes, and may suspend or terminate the offer or change the terms and conditions of this offer without prior notice.
 - i. The Company shall not be liable for any failure to enjoy the Limited Offer by the customer.
5. The Offer will be forfeited upon the occurrence of any of the following events: (a) if the Eligible Customer changes to a student plan from standard monthly plan; (b) if the Eligible Customer changes to a service plan with a monthly fee lower than that of the monthly plan selected at the time of subscription; (c) the mobile telephone service of the mobile telephone number is terminated for whatever reason
6. Eligible Customers agree that this Offer is for their own personal use and cannot be resold or exchanged for cash, vouchers, goods, or services.
7. Code redemption after quotas used up or after the Offer Period will not be accepted.
8. Customers of the Birdie Mobile service cannot enjoy the Offer in conjunction with other offers, except for the Rewards for Referees under the Birdie-Get Birdie referral programme.
9. The rebate paid by the Company hereunder will only be applied by the Company in the manner described hereunder to meet the Customer's payment obligations to the Company in respect of the account. Customers cannot offset any other sum payable to the Company against any part of the rebate payable by the Company to the account.

10. If a Customer's account is terminated for any reason(s), (as applicable) any Offer, payment or prepayment, entitlement to any waiver, rebate or data (including roaming data day pass) or rewards or points that are unused or pending to be rewarded to the account in any form, or any other unused items purchased or redeemed for the account, will be forfeited and not transferrable, restorable or refundable in any circumstances.
11. Customers who port in their existing number to the Company are advised to pay attention to the terms of their contracts with their current telecom service operator to avoid any penalties and/or related fees that may be imposed by their current telecom service operator.
12. In the event of the mobile number not being transferred to the Company's mobile service due to incomplete, wrong or false information provided by the customer or any grounds beyond the reasonable control of the Company, the Company has the right to cancel the relevant porting application. All offers will be forfeited without compensation and the Company shall not be therefor.

Notwithstanding any provisions of the applicable terms and conditions and/or service agreement, Birdie reserve the right to, with or without notice, terminate or suspend the Offer or the entitlement to the Offer or terminate any service agreement with the Eligible Customer or disconnect, suspend or restrict the services in whole or in part for any reason until the earlier of the end of the service term or any renewed term (if any) or such other date which Birdie may determine: if (a) it is in the opinion of Birdie providing the Offer and/or the service would cause it to be in breach of any applicable law, requirement of any competent authority or internal policy; (b) the Eligible Customer's mobile service with Birdie has been suspended or otherwise terminated; (c) Birdie discovers or reasonably suspects that (i) any information which the Eligible Customer provides is inaccurate, incomplete, false or misleading in any respect; and/or (ii) the Eligible Customer might have participated in any illegal, fraudulent, suspicious, deceptive, abusive or unfair behaviours or reselling or otherwise breaching the terms and conditions of Birdie or applicable laws and regulations.
15. Birdie reserves the right to revise these Terms and Conditions at any time without prior notice. This Offer is subject to change and is available on a first-come-first-served basis with limited availability. If Birdie believes that any Eligible Customer has acted in an abusive manner, Birdie may impose any administrative fees and/or terminate their entitlement to enjoy the Offer. In case of any dispute related to this Offer or these Terms and Conditions, Birdie reserves the final decision. The Offer is also subject to Birdie Terms and Conditions.

16. Birdie shall in no event be responsible for anything arising from any unauthorized use to any Eligible Customer's Birdie mobile service account at any given time including any fees or charges so incurred and shall in no event be liable for any suspension or termination of the Offer.
17. In the event of any discrepancies between the Chinese and English versions, the English version shall prevail.
